5. Police Matters (5 min)

Police Report 14th June - 12th July 2018

Between the 14th June and the 12th July 2018 there were a total of 15 crime Occurrences.

During the above time period there were zero reported Anti-Social Behaviour reports from local residents.

There were 4 incidents of violence throughout this time.

There was 2 thefts within this period.

There were 3 burglaries within this period.

There was 3 incident relating to damage during this period.

There was 2 fraud occurrence.

Officers are continuing to patrol the area on a regular basis and also calling in to see local residents at coffee mornings. PCSO's have been patrolling the park on Ty'r Winch following some reports of drug paraphernalia being found at the location.

St Mellons officers have actively engaged with the local Muslim community over the month of Ramadan – we have attended at the St Mellons Community Centre where the Mosque is situated and look to have some community engagement events throughout the summer. We are working closely with the members of the Muslim community in organising joint events for the community.

St Mellons Neighbourhood Team along with Cardiff Council Off-Road Motorbike team conducted a joint operation on Saturday 30th June 2018 whereby 3 off road bikes were seized. Officers have been aware of ongoing issues with ASB being caused by motorcycles in the area. Operation Red Mana has commenced in relation to off road motorcycle annoyance – joint operations will take place monthly with the council with a view to targeting and removing the off-road bikes from the roads.

The access point at The Coach House is every Tuesday 1100 – 1200 hours, officers are available to speak to members of the community regarding any issues they would like to discuss, or if they would like to speak to officers in confidence they can contact them via email or mobile to arrange a meeting.

St Mellons shopping precinct remains a way-marker for our area and at the moment. There is a concerted effort from PC's and PCSO's alike to target this location with a view to reducing the number of ASB calls we have previously had.

The PCSO's and myself are available should you wish to utilise us for any particular event that may be planned in the future. There will be two PCSO's attending the Fete this Saturday.

The bank reconciliation spreadsheet to 30th June 2018 has been emailed to Councillors and the RFO pointed out there are 16 cheques to be approved and signed. The cheques include the recommended IRP for Wales payment to each councillor in respect of out of pocket expenses for 2018/19. On the Income side, the Village Association have made a donation of £1,000 towards the construction of the Boules courts. The RFO reported that he had complained again to our bankers as the bank statement has not been received and he obtained copies to complete his reconciliation. He also obtained the necessary forms to update the bank mandate, which have been handed to the Chair.

The annual gas risk assessment report for the Hall has been received with no issues, however the usual contractor responsible for the annual electricity testing on the Hall and Pavilion has not responded and failed to give any dates. In the circumstances, another local qualified electrical contractor has been instructed to carry out minor repairs to the Pavilion before undertaking the annual testing. The Village Hall meeting with the Council regarding the Section 106 monies will initially require roof tenders and the RFO requires 4/5 copies of the original roof plans to obtain estimates by the September meeting. The RFO will also forward councillors the Budget to Actuals comparison for the period April – August for discussion at the September meeting.
